Parent satisfaction survey

Every year after the Easter Break, we ask parents to give us feedback on their experience of GIS. All parents received links to PYP and MYP surveys on 20 April. We would be grateful if you could take some time to answer a set of questions, which will help us make plans for next academic year.

Report from UDIR

Please find attached a copy of the letter to parents and students following the UDIR inspection. The letter has already been shared with the Student Council.

The matters to be addressed include:

- 1. Representation on the school board The report points out that local authorities, parents, students and staff should have their representatives on the school board. The status of the representatives should be that of an observer, not member. This was the original arrangement when the school opened in 2015. However, later it was considered advantageous to 'promote' the parent and teacher observers to become members of the board with voting rights. It was felt that as members both representatives have more influence in the decisionmaking process. The fact that parent and staff representatives were members, not just observers, was praised by the IB PYP verification visit team. However, the UDIR inspection pointed out that the role of a member is different than that of an observer and that both representatives should be observers on the board. This will be addressed in tomorrow's extraordinary annual meeting. As regards the student representative as well as a representative of local authorities, they have attended board meetings since 1 February 2022.
- 2. Calls for board meeting

The inspection concluded that calls for board meetings had been sent too close to the meetings and should be sent out at least seven days prior to each meeting. Case documents should be sent out 4 days prior to a meeting. No participant in a board meeting has ever raised this as an issue that might have an impact on the operations of the board. However, we have already implemented the recommendation since January 2022.

- Informing parents and students of their rights regarding school environment
 - The report states that the school has not informed parents and students about their rights regarding school environment, including the right to file a complaint with the state administrator.
 - As you may remember, this information was communicated to parents by homeroom teachers during the Meet the Teacher evening. Similarly, students were informed by the head of school in the first meeting with the Student Council this academic year. We are open to any suggestions you may have to make our communication more effective. Please contact Mr Armanski if you want to share suggestions.
- 4. School board practices
 The report states that the board needs to review its processes to ensure they are effective. This work is also underway.

The school has until 24 May to address the matters outlined in the report.
